SUMMARY OF LAST YEAR'S MEETINGS

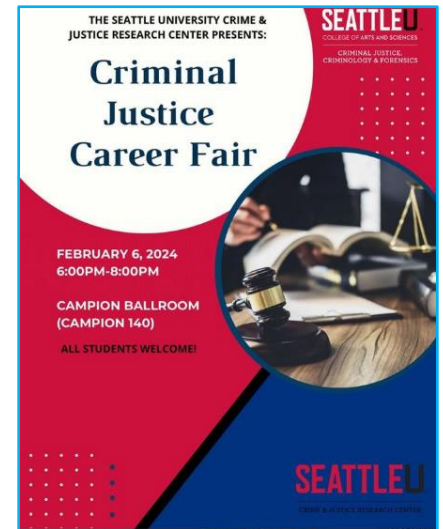
In our 2023 annual luncheon we posed the question to advisory committee members - *If you had the opportunity to give a "last lecture" to our students on what they need to know to be criminal justice professionals who, in the spirit of the SU Mission will go on to "educate leaders for a just and humane world," what would the title and focus of your lecture be?* We discussed how we could incorporate ideas from these lectures into our curriculum and work with students. Our annual *Innovation in Criminal Justice Education Award* for 2023 went to the FBI's **Debi Dorfsman** and our 2023 *Distinguished Alumni Award* went to **Steven Jenkins**, BACJ '17 (posthumously). At our mid-year meeting, Dr. **Matt Hickman** presented his research -Building the Washington State Data Exchange for Public Safety (WADEPS).

Departmental Update

ENROLLMENT/STUDENT INTEREST

We begin the 2024-2025 academic year with **335 students- 253 undergraduate students, 82 graduate students, and 2 Crime Analysis Certificate students.** In the undergraduate program, forensic psychology is the most popular specialization with 87 students – 50 BA/37 BS (34% of all CJ undergrads) followed by Criminology with 70 students (28% of all CJ undergrads), forensic science with 53 students – 3 BA/50 BS (21% of CJ undergrads), and Administration of Justice with 25 students (10% of all CJ undergrads), and law with 18 students (7% of all CJ undergrads). The most popular graduate program specializations are MACJ-No Specialization with 31 students (38% of all MACJ students) followed by Investigative Criminology with 30 students (37% of all grad students) with the remainder of the students in Victimology with 10 students (12% of all grad students), the Research and Evaluation specialization with 6 students (9% of all grad students), and the MACJ/JD with 4 students (5% of all grad students).

Our MACJ Program has strong continued enrollment. For the 2024-2025 academic year, we have **27** incoming MACJ students both in the on-ground and new online program! The selected students attending our program are from the local area and out of the state and country. Our new students are graduates of Binghamton University-SUNY, Central Washington University, Eastern Kentucky University, Galen College of Nursing-San Antonio, Guru Nanak Dev University, Kabarak University, Kwantlen Polytechnic University, Rocky Mountain College, Saint Michael's College, Seattle University, University of Kentucky, University of Massachusetts, University of Washington-Seattle, University of Washington-Tacoma, and Washington State University.



Student Awards and Departmental Honors

The undergraduate commencement awards include the *Kelliher Award* for the highest GPA in the major and the *Corr Service & Ethics Award* named for CJ Department co-founder Eugene Corr, former Assistant Police Chief for the Seattle Police Department honors a graduating senior in the Criminal Justice Department undergraduate program who has made significant service and ethics contributions to the criminal justice system. The 2024 Kelliher awardees were **Klara Davis** (BSCJ-Forensic Psychology) and **Hana Azzam** (BSCJ-Administration of Justice) and the Corr Service & Ethics Award was awarded to **Quinn Priebe** (BSCJ-Forensic Science).



In 2024 we launched the first-ever *Steven Jenkins Academic Achievement Inspiration Award*. This award goes to a graduating undergraduate or graduate student who has achieved academic success in the face of hardship, has persevered, and who is an inspiration to others. The award is named after Steve Jenkins who was an SU Student Athlete and 2017 Criminal Justice graduate. The first recipient of the Steven Jenkins Award went to **Jacob Berry** (MACJ- Investigative Criminology) who embodies this resilience through his academic accomplishments in the face of adversity, shining as a source of inspiration for others.



The 2024 *Norm Maleng Academic Excellence and Citizenship Award* went to **Bailey Tanaka** (MACJ). Bailey will pursue a PhD in Sociology at the CUNY in New York City. The award is named in honor of Norm Maleng, former King County Prosecutor. Norm was a CJ Department Advisory Committee member who was instrumental in inspiring the inclusion of the Victimology Graduate Specialization. Selection is based upon exceptional graduate work in the classroom and service to the community. Norm's family Judy and Marm Maleng presented Joslyn with the Maleng Award.



The *Blume Criminal Justice Scholars Program* was established in 2016 through a generous gift to our department from Ann and Bruce Blume to support advances in research and practice at the intersection of criminal justice and mental health. The award goes to an undergraduate and graduate student in their final year of study. The 2024-25 Blume scholars are Undergraduate Blume CJ Scholar Award: **Talia Friedman** Graduate Blume CJ Scholar Award: **Olivia Crawford**

The *Corr Scholarship* goes to the incoming graduate student who honors Seattle Police Department Assistant Chief Eugene Corr's vision to increase women and minorities in law enforcement. The 2024 Corr Scholarship was awarded to MACJ/Investigative Criminology student **Ella Vermiere**.



Additionally, the *Hellenkamp Award* honors Marion Hellenkamp who was the first female African American woman promoted to Lieutenant in the LAPD and is awarded to exceptional continuing students: **Ava Getz, Darion Lamell, Kalani Ledesma, Kierra Lee, and Gustavo**

Marquez, each of whom has demonstrated remarkable dedication and excellence in their respective fields. Furthermore, **Olivia Crawford and Sage Svedin** have been chosen as the *ASGC Representatives*, honored for their leadership and commitment to serving the community. Crime & Justice Research Center Collaborations

In 2023-24 the reports for these projects were produced by last year's research teams.

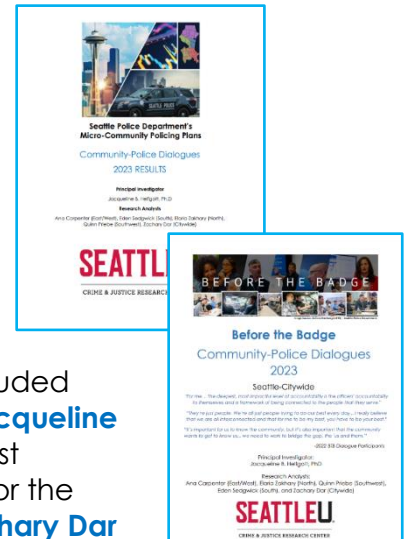
- **Seattle Police Department's Citywide 2023 Seattle Public Safety Survey Results**

In the 2023 Seattle Public Safety Survey Report, Principal Investigator **Jacqueline B. Helfgott** with **Matthew Hickman** and MCPP RAs **Ana Carpenter**, **Elaria Zakhary**, **Eden Sedgwick**, **Quinn Priebe**, and **Zachary Dar**, reported Seattle public safety concerns. The report identified traffic safety, police capacity, property crime, homelessness, and community capacity as the main concerns across Seattle's neighborhoods. It also highlighted the Seattle Police Department's MCPP initiative, which focuses on enhancing public safety through collaborative police-community efforts tailored to the unique needs of each neighborhood.



- Seattle Police Department’s Micro-Community Policing Plans Community-Police Dialogues and Before the Badge Community-Police Dialogues**

The 2023 SPD MCPP Community Police Dialogue and Before the Badge Dialogue Reports presents themes from the SPD MCPP Community-Police Dialogues and Before the Badge Dialogues with new Seattle police recruits. The dialogues enhance understanding and trust between the community and police, contributing to more effective and responsive policing strategies. The discussions focus on crime and public safety concerns with themes varying by precinct. Common themes included public order, property crime, and police-community relations. **Jacqueline B. Helfgott** and **Ana Carpenter** led the discussions for the East/West precincts, **Eden Sedgwick** for the South precinct, **Elaria Zakhary** for the North precinct, **Quinn Priebe** for the Southwest precinct, and **Zachary Dar** for the Citywide precinct.



- Seattle Police Department’s Before the badge Longitudinal Evaluation and Before the Badge Community - Police Dialogues**

Jacqueline B. Helfgott (Principal Investigator) and **Matthew J. Hickman** (Co-Investigator) with student Research Analysts **Jacob Stein**, **Quinn Priebe**, **Elaria Zakhary**, and **Ethan Dieckmann** completed the one-year project report for the longitudinal evaluation of the Seattle Police Department’s "Before the Badge" (BTB) recruit training. BTB engages new recruits in training involving community engagement, wellness, systemic racism prior to Basic Law Enforcement Academy. This report presents results from the first year of the three-year longitudinal evaluation.



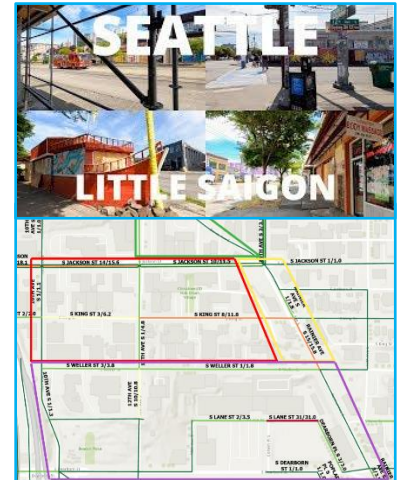
- Rainier Beach A Beautiful Safe Place for Youth Evaluation**

The Seattle University Crime & Justice Research Center has partnered with Rainier Beach: A Beautiful Safe Place for Youth (ABSPY) to conduct research on crime and perceptions of crime to enhance public safety in Rainier Beach. This project is an extension of previous work conducted over the past ten years by George Mason University/Dr. Charlotte Gill. The research was led by **Dr. Jacqueline Helfgott** (Principal Investigator) and **Dr. Matt Hickman** (Co-Investigator) and student Research Analysts **Kalista Brush**, **Kierra Lee**, **Alondra Martinez-Villalobos**, and **Sara Rashid**.



- **Seattle Police Micro-Community Policing Plans Little Saigon Evaluation**

The Little Saigon Evaluation examines the implementation of Crime Prevention through Environmental Design strategies in Seattle's Chinatown/International District – Little Saigon neighborhood. This project utilizes data from the SPD MCPP Seattle Public Safety Survey compared with crime data in the neighborhood to examine the impact of CPTED. The research is led by **Dr. Jacqueline Helfgott** (Principal Investigator) and **Dr. Matt Hickman** (Co-Investigator) with student Research Analysts **Ava Getz, Talia Friedman, and Alondra Martinez-Villalobos.**

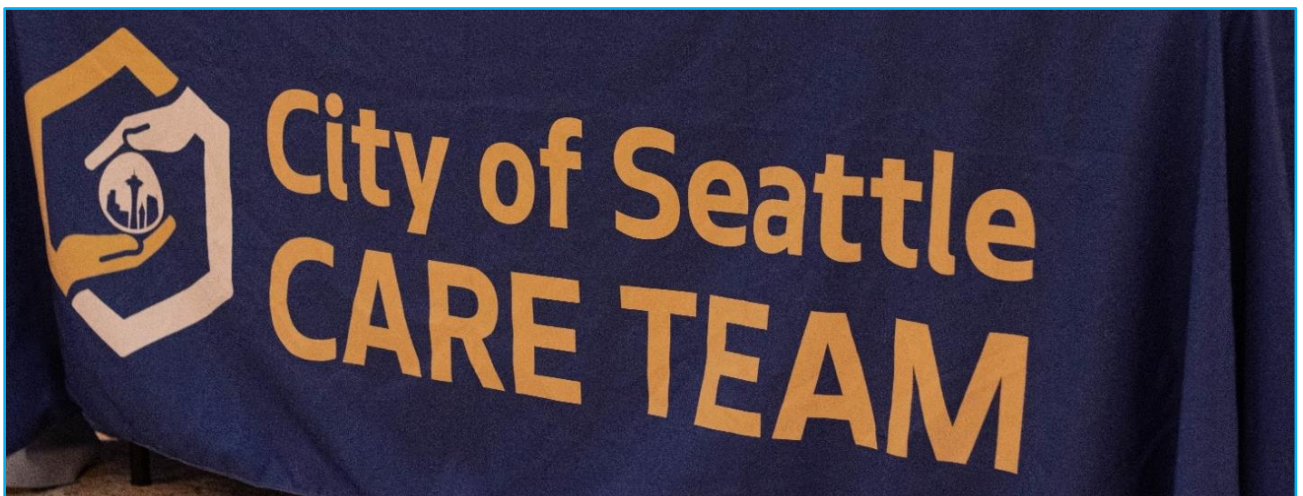
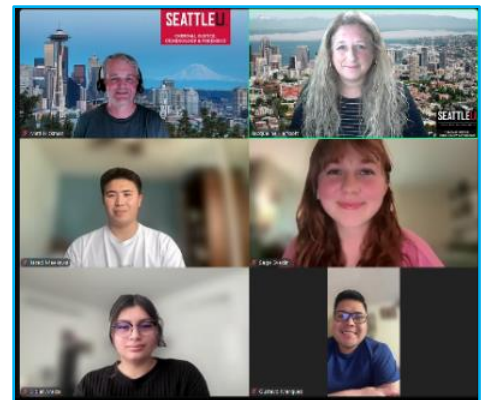


- **Evaluation of the Seattle Community Assisted Response and Engagement (CARE)**

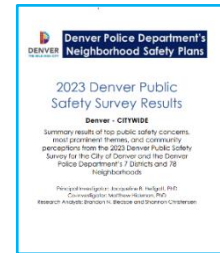
The evaluation of the Seattle CARE program examines the implementation of Seattle's third branch of public safety. The study involves interviews with CARE staff and CARE collaborative partners and analysis of calls for service and CARE statistics to examine the impact of CARE in Seattle. The research is led by **Dr. Jacqueline Helfgott**



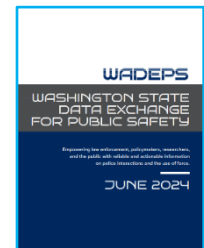

Denver Police Department's Micro-Community Policing Plans was launched for the first time in 2023, the first official replication of the SPD MCPP in another city. This will be a collaboration with the Denver Police Department with **Jacqueline Helfgott**, **Matt Hickman**, and MACJ alums and former SPD MCPP Research Analysts **Brandon Bledsoe** and **Shannon Christensen** working on the project.

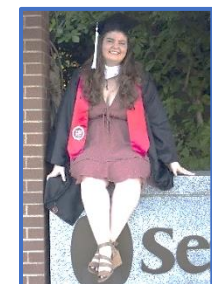


- **Matt Hickman** is working with Washington State University on the Washington State Data Exchange for Public Safety (WADEPS). The WADEPS is an online platform designed to help law enforcement agencies meet new statewide use-of-force reporting and public accessibility requirements,



- **Can the Results Be Trusted? Assessing the Reliability of In-Home Drug Tests for the Detection of THC in Urine**

Congratulations to **Jennifer Huffman** and **Madison Calvert**, both 2023 Criminal Justice BS graduates with a specialization in Forensic Science! Their paper, "Can the Results Be Trusted? Assessing the Reliability of In-Home Drug Tests for the Detection of THC in Urine," co-authored with **Éabha R. Finn** and **Dr. Kristen Skogerboe**, has been published in Volume 8 of the Seattle University Undergraduate Research Journal (SUURJ).



- **Parents as a Nonshared Environment Factor: A sibling Barricade**

Analysis Professor **Bridget Joyner-Carpanini** and **Kevin M Beaver** study on that explores how parenting practices differ among siblings within the same family. The research uses sibling barricade models to analyze whether parents' behaviors towards one sibling affect the other siblings.



- **Trait- Based Explanations of the Victim/ Offender overlap**

Professor Bridget Joyner-Carpanini and **Kevin M Beaver** on another study that explores the connection between victimization and offending. The researchers focus on whether certain personality traits, such as low self-

control, Machiavellianism, and callous-unemotional traits, can distinguish individuals who are solely victims, solely offenders, or both.

CONTINUING EDUCATION AND PROFESSIONAL TRAINING AND PROFESSIONAL SERVICE

On May 9, 2024, the Crime & Justice Research Center held our annual continuing education event (virtually for the 5th year) – “*Digital Criminology*.” The event featured keynotes by Dr. Gregory Stratton and Dr. Robin Cameron from RMIT University, Melbourne, authors of *Digital Criminology* and Dr. Sanja Milivojevic, University of Bristol United Kingdom, author of *Crime & Justice in the Future Internet* including panelists Dr. Ray Surette, University of Central Florida, author of *Copycat Crime and Criminals*, Dr. Jacqueline Helfgott, Seattle University author of *Copycat Crime: How Media, Technology, and Digital Culture Inspire Criminal Behavior and Violence* and Loren Atherley, and Captain James Britt from the Seattle Police Department. We had over 250 registrants from regions local, state, national, and international. The event was certified for Continuing Legal Education credits.

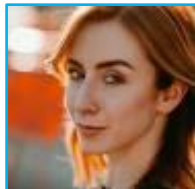
Li Huang completed her Ph.D. in Criminology, Law and Society at the University of California, Irvine. Her research has focused on white-collar and corporate crime, courtroom decision-making, and comparative justice systems. Her latest research project investigates corporate prosecution and punishment in the U.S. from a sociolegal perspective to understand the underenforcement of corporate crime in a neoliberal society. Li Huang has authored several articles published in peer-reviewed journals in both English and Chinese. Prior to her Ph.D. program, she pursued legal education in the U.S. and China. She is a member of the New York Bar.



Dr. A Johannes **“Jon” Bottema** was previously an Assistant Professor and the Security Studies Program Coordinator in the School of Criminal Justice, Forensic Science, and Security at The University of Southern Mississippi. His Ph.D. is in Criminology and Criminal Justice, which he received from Arizona State University. Dr. Bottema focuses on collaborating with law enforcement at various levels to conduct practical research that positively impacts agencies and the communities they serve. 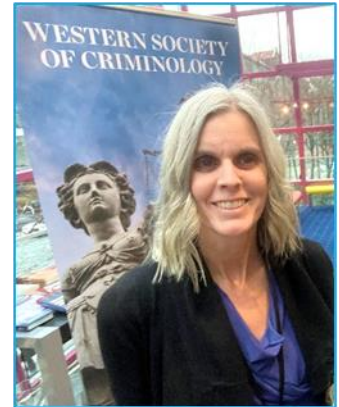

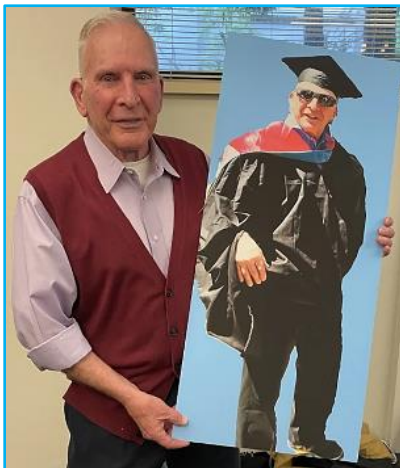


Faculty Promotions, Service, and Awards

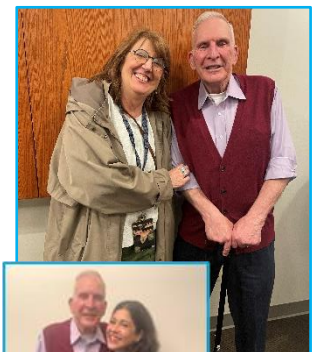


- Drs. **Pete Collins** and **Brooke Gialopsos** recently completed their contract work with the Washington State Administrative Office of the Courts that explored the demographic diversity of summoned jurors. Their 2024 final report (available here) was instrumental in creating RCW 2.36.180, which codified their demographic survey as a crucial data collection tool for Washington State. Their work also helped pave the way for the current \$1.5 million pilot project in Pierce County to evaluate the impact of raising jury pay to \$100 per day. The survey has received an enormous response, hitting over one million! Also,

- **Dr. Jacqueline Helfgott** won 2nd place (with Seattle Police Department, Denver Police Department, and Hello Lamp Post) in the National Institute of Justice (NIJ) Innovation in Measuring Community Perceptions Challenge for her work on the Seattle and Denver Public Safety Surveys.
